Promoting e-Learning with "Bring Your Own Device (BYOD)"

In order to match with the Government's "The Fourth Strategy on IT in Education (ITE4)", the Education Bureau has proposed the project "Enhancing School's Wi-Fi infrasture-WiFi900". Our school selected as one of the pilot schools has gained the grants to enhance the school's Wi-Fi equipment in order to aid e-Learning. Much research shows that e-Learning increase students' interest in learning, promotes the interactions between students and teachers and caters for learner diversity positively. In general, educators believe that BYOD is a key factor in the success of e-Learning. Therefore, our school will implement the BYOD project for the Form 1 to Form 3 students whereas Form 4 to Form 6 students will undergo a pilot scheme this school year. Students will use their own mobile device (iPad) to participate in learning activities in school.

The Community Care Fund (CCF) will implement an assistance programme, Provision of Subsidy to Needy Primary and Secondary Students for Purchasing Mobile Computer Devices to Facilitate the Practice of e-Learning, starting from the 2018/19 school year for three years, to subsidize the student who is receiving Comprehensive Social Security Assistance Scheme (CSSA) or full grant/half grant of the School Textbook Assistance Scheme to purchase mobile computer devices. During the three-year implementation period, each eligible student will receive the subsidy for purchase of a mobile computer device once. Parents should declare if it is the student's first application or not. When a student beneficiary is promoted or has changed to a new school using a different device and the original device could not meet the learning needs in the new school, the beneficiary could then apply for an additional subsidy for purchasing a new device. In such case, the student concerned is required to return the used device to the original school. The original copy of the 'Proof of Returning Mobile Computer Device' should be attached for proof. If it is found that there is a repeated use of subsidy without declaration, parents have to purchase that iPad at its original

To minimize the expense from parents, we will make a group purchase through suppliers. Parents can use their discretion to decide whether or not to buy the mobile device from them. However, the above subsidy will not be received under yours discretion. Besides, our school can provide the iPad lending services for those families in need.

We select "Senco-Masslink Technology Ltd" as the suppliers to make a group purchase of mobile computer devices. The details are as follows:
