## **Gleeful E-learning Journey**

Thanks to the Hong Kong Bank (HSBC) Charity Fund that generously funded St. James' Settlement on promoting an e-Learning Support Scheme with "Gleeful E-learning Journey". The scheme aims at supporting the online learning of primary to junior secondary students with free digital devices in order to enhance enhancing the digital literacy of students and parents.

- 1. - 2. Families who are not eligible to apply for the "Community Care Fund (CCF)" but are facing financial difficulties.

\*Families who apply this scheme must meet one of the above criteria and it is on a first come first served basis. All successfully applicants of the scheme must participate in the parent seminars and parent-child activities provided by the organizer to strengthen their knowledge and skills in supporting their children's online learning.

- 2. A mobile data card with a Wi-Fi device (Wi-Fi egg)
