Dear Visitors,

To safeguard the health and safety of our visitors, staff and animals, visitors are required to fulfill the following criteria to enter Ocean Park:

1. Visitors should not have any of the following symptoms now and within 14 days prior to the date of visit:
 - fever, respiratory infection, shortness of breath, sore throat, diarrhea, loss of taste or smell.
2. Visitors should not be under any Compulsory Quarantine Order or Compulsory Testing Notice now or on the date of visit.
3. Visitors should not have been in close contact with any person who is a confirmed or preliminary positive case of COVID-19 infection in Hong Kong or overseas now and within 14 days prior to the date of visit.
4. Visitors should not enter the park if there is any changes in one's health condition or one fail to fulfill the above criteria on the date of visit.

Ocean Park has the right to refuse entry to any visitors if they violate any of the above criteria.
